	3 games each event on 1 st day. Pairs teams and singles will be put into flights on day 2. Fours format to be determined by Tournament Committee. All players return on 2 nd day for at least one game. Single re-spot rule in effect. Equal distance bowls: zero shots, end played.		
Participants	Must be a member of Bowls USA and Southeast Division if residing in the Southeast Division for more than 30 days. Non-residents of less than 30 days must be Bowls USA or WBA affiliated members.		
Entry Fee	\$30.00 (USD) PER PERSON / PER EVENT Please complete entry form and return with players' names and entry fees. Please consolidate entry forms as much as possible.		
Dress Code	White or matching-colored team shirts with collars. White or matching-colored slacks, or shorts. Footwear must be flat-soled and heel-less.		
Notes	To qualify for Bowler of the Tournament, a player must enter and play in all three events. Coffee, tea, water and sweets will be provided in the mornings. Refreshments will be available all day. Lunch is available for purchase each day.

OTHER CONDITIONS OF PLAY

- All games shall be played in line with the Laws of the Sport of Bowls, Crystal Mark 3rd Edition, and in accordance with the Domestic Regulations as approved by World Bowls.
- Appendix A.4. Restricting the movement of players (trips to the head) will be in effect.
- Appendix A.5. Regulations regarding slow play may be invoked if needed to keep on schedule and to avoid imposing a time limit on games.
- Time limits for games will only be imposed if the Tournament Committee deems it necessary for reasons of slow play, inclement weather, or unforeseen circumstances.
- Draw: Effort will be made to avoid teams from same club playing against each other on 1st day.
- Rink assignments: No team will play twice on the same rink on 1st day. On 2nd day, some teams may play on rink assigned on previous day, if necessary.
- Scoring: Wins -- Ties -- Losses
 - Day 1: Three points are awarded for a win. One point for a tie. No points for a loss. All games played to completion on day 1. No extra ends. Ties will stand.
 - Day 2 only: In case of a tie, an extra end will be played to determine the winner.
- A bye is considered a win. Teams/Players with a bye can practice on a rink assigned by Umpire as available.
- Late arrival: A team or player more than 10 minutes late to play after the official start time will incur a penalty of one shot. After a 20-minute delay, the game is forfeited. Appeal can be made to the Tournament Committee.
- Game stoppages: If a game is suspended due to inclement weather or unforeseen circumstances, the Tournament Committee will determine if/when the game will continue. If the game cannot be resumed, it will count as a played game if all teams have completed 9 ends or 12 shots in singles.
- Order of ranking based on: Points, then Net total of shots (max. 10 plus shots), then shot percentage.
- In the event of a tie in round-robin play (if used), first order of ranking will be head to head.
- On day 2, Pairs and Singles will play in a flights format. The format for Fours will be determined by number of entries and announced at the event.
- Substitutions: As approved by Tournament Committee. No substitutions in Singles after play has commenced.
- Cell phones must be turned off or muted. Exceptions made only in emergencies and with prior approval by Umpire.
- Drop-outs: In Singles, if a drop-out occurs after completion of play on day 1 and prior to commencement of play on day 2, the flights will be re-ranked with the bye(s) moved to the last flight.
- Smoking in designated areas only.
- Local rules in effect: No running on the green; walk up and down in the center of the rink.
- Umpires: To be appointed by SED Head Umpire. Singles markers will be assigned as available.
- Tournament Committee has the discretion to determine and/or modify the tournament format and Conditions of Play. Some conditions as stated here may differ in part from the Policies and Procedures. Other conditions as published on the SED website may be enforced at discretion of the Committee.
